



GAME RULES AND REGULATIONS

1. ABOUT THE DAILY LOTTO /DAILY LOTTO PLUS

- 1.1 The following are the essential game features for the DAILY LOTTO /DAILY LOTTO PLUS:
 - 1.1.1 The National Lottery game in which the Participant selects, or has the Lottery Processing System randomly assign five (5) numbers from a range of 1 through 36, inclusive, shall be called "DAILY LOTTO" and all the National Lottery Tickets issued for this Game shall be clearly identified with the name of the Game and the date(s) of the drawing(s) for which they are issued. DAILY LOTTO PLUS is an add-on game that can only be played if the player plays DAILY LOTTO.
 - 1.1.2 Participants must be 18 years or older to play any of the National Lottery Games.
 - 1.1.3 The cost of each DAILY LOTTO Board Game will be R3.00 inclusive of VAT.
 - 1.1.4 The cost of DAILY LOTTO PLUS will be at an additional cost of R1.50 inclusive of VAT.
 - 1.1.5 The total numbers to be selected per entry shall be 5 numbers.
 - 1.1.6 The maximum price for a wager is limited to R180.00 per participant per Bet slip for DAILY LOTTO and R270.00 per Bet slip for DAILY LOTTO PLUS (6 Boards).
 - 1.1.7 Players can play through traditional retail channels at stores with Lottery terminals or via the National Lottery website and Mobile Applications on Android and iOS devices. They may also play via Lottery Banking partner Apps and authorized retailers with hand-held devices.
 - 1.1.8 Players can play at terminal level or via the National Lottery website with the maximum wager price to the value of R900.00 inclusive of VAT (20 boards of DAILY LOTTO including DAILY LOTTO PLUS for 10 advanced draws).
 - 1.1.9 Players can choose their own numbers or select a "QUICK PICK" option whereby the system will generate a random set of numbers to be entered into the draw.
 - 1.1.10 The Participant in retail stores will have the option to fill out their selections using a DAILY LOTTO Bet Slip or by asking the retail clerks to make their selections on their behalf using the lottery terminal.
 - 1.1.11 Players may also ask the retail clerk for a "QUICK PICK" selection for up to a maximum of 20 Boards/entries at terminal level and up to a maximum of 10 advanced draws.
 - 1.1.12 The daily play limit for DAILY LOTTO is R2,000.00 per participant and R1,000 for DAILY LOTTO PLUS.
 - 1.1.13 When a player selects their numbers or opts for a "QUICK PICK" selection on any DAILY LOTTO Board, and then opts to Play DAILY LOTTO PLUS, then the numbers that were selected for the DAILY LOTTO Game will be the same numbers that are also entered into the DAILY LOTTO PLUS draw.



- 1.1.14 A player may at any time cancel their selections before placing a wager on a Bet Slip by selecting the Cancel option.
- 1.1.15 If any Entry is rejected by the Terminal or website, there is no valid Entry into the draw.
 - 1.1.16 If the Entry is not submitted on the on-line play with a Ticket / Receipt number, the Entry shall not be valid.

2. STATUS OF THESE RULES

- 2.1 These rules are for the DAILY LOTTO & DAILY LOTTO PLUS Game(s), which constitute the contractual rights and obligations of ITHUBA to Participants, as may be amended from time to time.
- 2.2 In the event of a discrepancy or inconsistency between these Rules and the conditions and/or explanations being advised during a purchase, these Rules shall take precedence.

3. PLAYING THE DAILY LOTTO AND DAILY LOTTO PLUS GAME(S)

- 3.1 ITHUBA will make the DAILY LOTTO & DAILY LOTTO PLUS Game(s) available for sale to the public at such cost stipulated under paragraph 1.1.3, 1.1.4 or as ITHUBA may from time to time determine.
- 3.2 In order to Play DAILY LOTTO PLUS, the Participant must play the DAILY LOTTO Game(s) first.
- 3.3 The Participant may participate in the DAILY LOTTO and DAILY LOTTO PLUS Game(s) by:
 - 3.3.1 Presenting a completed Bet Slip to a Retailer. On any one Bet Slip, a Participant may make a Selection from a minimum of one Board and a maximum of the number of Boards included on the Bet Slip. Each Selection is made by manually marking 5 (five) numbers within one Entry to the draw per Board or by manually marking the "QUICK PICK" box on the Bet Slip. The completed Bet Slip is processed through the Terminal, which will issue the Ticket recording each Selection marked on the Bet Slip.
 - 3.3.2 Entering a Selection of 5 numbers between 1 and 36 per Board on the on-line play or selecting a QUICK PICK on-line.
 - 3.3.3 Playing a Quick PICK Selection through USSD play;
 - 3.3.4 Indicating in person to a Retailer the requested digits or numbers to be entered manually into the Terminal by the Retailer;
 - 3.3.5 Requesting a number Selection to be made on a random basis by the Lottery Processing System through a QUICK PICK. Selecting random set of 5 (five) numbers through any Alternative Sales Channel where a Participant can purchase an Entry into the DAILY LOTTO & DAILY LOTTO PLUS Game(s), the Participant will be issued



with a valid Ticket or Receipt, whichever is applicable through the different platforms of purchasing the National Lottery Game.

- 3.3.6 Selecting numbers manually or by QUICK PICK using the players Banking App.
- 3.3.7 Requesting numbers to be selected from a mobile hand-held terminal vendor or requesting a QUICK PICK (limited to one draw per transaction, up to twenty entries per ticket).
- 3.3.8 Tickets purchased via retailer in-lane channels can only request QUICK PICK options.

4. DRAWS

- 4.1 The DAILY LOTTO and DAILY LOTTO PLUS Draws will take place daily except on 25 December (Christmas Day). Sales on 25 December will be enabled and will be included to the sales for the next day's draw.
- 4.2 The two Draws shall take place consecutively - DAILY LOTTO draw numbers will be drawn first followed by the DAILY LOTTO PLUS numbers.
- 4.3 Each draw will select Winning Numbers with the aid of drawing equipment used by ITHUBA.
- 4.4 In each Draw, five (5) numbers will be drawn at random from a random number generator (RNG) system.

5. WINNING SELECTIONS (PRIZE DIVISIONS)

The winning selections otherwise known as Prize Divisions are structured in the same way for DAILY LOTTO and DAILY LOTTO PLUS. There are 5 Prize Divisions for each of the two games:

- 5.1 A Participant who, in respect of any Selection, has two or more numbers which match the winning numbers for any of the relevant winning prize Divisions will be entitled to a Prize in the highest prize category to which those numbers relate.
- 5.2 **Prize Division 1- Match 5 (The Jackpot Prize)**
Means that the Participant has correctly matched five numbers in any one Selection from the five drawn numbers. The appropriate Prize category is called MATCH FIVE OF FIVE MAIN NUMBERS ("MATCH FIVE" or also referred to as "THE JACKPOT").
- 5.3 **Prize Division 2 - Match 4**
Means that the Participant has correctly matched four numbers in any one Selection from



the five drawn numbers. The appropriate Prize category is called MATCH FOUR OF FIVE NUMBERS (“MATCH FOUR”).

5.4 Prize Division 3 - Match 3

Means that the Participant has correctly matched three numbers in any one Selection from the five drawn numbers. The appropriate Prize category is called MATCH THREE of FIVE NUMBERS (“MATCH THREE”).

5.5 Prize Division 4 - Match 2

Means that the Participant has correctly matched two numbers in any one Selection from the five drawn numbers. The appropriate Prize category is called MATCH TWO of FIVE NUMBERS (“MATCH TWO”).

6. PRIZE POOLS – DAILY LOTTO & DAILY LOTTO PLUS

6.1 The Prize Pools for DAILY LOTTO are different to the prize pools for DAILY LOTTO PLUS and are shown in the following prize tables:

Subject to rounding down, the amount allocated by ITHUBA to the Pool Fund for payment of Prize(s) for a Draw shall be a percentage of the net sales of Entries made into that Draw or such larger amount as shall be determined by ITHUBA in its sole and absolute discretion.

Prizes are pari-mutuel, there are no fixed guaranteed winnings for the DAILY LOTTO and DAILY LOTTO PLUS except occasionally as and when a guaranteed jackpot is applied.

6.2 The allocation of the Prize Pool Fund to each of the remaining Prize Divisions shall be in accordance with the following provisions:

- 6.2.1 In the event that there are no winners in Division 1, then the Prize Pool for this Division shall be rolled over to the next Draw's corresponding Division.
- 6.2.2 In the event that there are no winners in Division 2, then the Prize Pool rolls down to the lower Division, i.e. Division 2 to Division 3.
- 6.2.3 In the event that there are no winners in Division 3, then the Prize Pool rolls down to the lowest Division, i.e. Division 3 to Division 4.



6.2.4 In the unlikely event that there are no winners in Division 4, then the Prize Pool rolls over to Division 1 of the next draw.

6.2.5 Share amounts shall be rounded up or down to the nearest 10 cents as follows: E.g. R1.55 shall be R1.60; R1.54 shall be R1.50.

7. GLOSSARY

7.1 The following words and terms, whenever they appear in these Rules, shall have the following meanings, unless the context clearly indicates otherwise:

Alternate Channel

The point of sale other than the Terminal where a player can purchase an Entry into the National Lottery Games. The player will be issued with a valid Ticket. Alternative Channels include the National Lottery websites, In-Lane (at selected Retailer outlets), Banking Channels, hand-held devices, Mobile Applications, Mobile Phones, USSD and any other additional channels.

Bet Slip

A preformatted form bearing the numbers from which a player can make his/her Selection to make wager for National Lottery Games.

Board

The Section/play area on a Bet Slip or graphical user interface where the numbers are selected defining an entry into the draw.

Breakage

The remaining funds per prize division after allocating rounded-off winnings.

Central Lottery System

The Central Lottery System is the Paytronix Lottery Systems (PLS), the main Lottery Solution to which all other systems are connected, in order to perform Lottery functions. The system is defined as the Paytronix Lottery System (PLS).

Prize Division

The prize tiers which a player may win a prize according to the defined prize structure for each division.



Draw

The process to match the winning tickets based on the numbers drawn by the RNG.

Entry

A transaction by which a player's entry into the National Lottery Games has been recorded as a transaction on the Central Lottery System. The Central Lottery System allows for multiple Entries.

Game

The National Lottery Games as detailed in the rules, which shall include any game, scheme, arrangement, system, plan, promotional competition or device which comprises a Constituent Lottery.

ITHUBA Holdings (RF) (PTY) LTD

The third National Lottery Operator licensed under the Lotteries Act No. 57 of 1997, as amended, to operate, conduct and promote the National Lottery and Constituent Lottery games in South Africa.

Mobile App

A method to play online via the National Lottery Mobile App and view results. This is available on Android and Apple iOS.

Net Sales

Is the total sales value of tickets in a draw which excludes cancelled tickets (i.e. gross sales less cancellations)

National Lottery

The National Lottery games licensed to ITHUBA to operate in South Africa.

Participant / Player

A member of the public (a player) over the age of 18 who purchases a National Lottery Game(s) Ticket(s).

Prize Pool

The amount allocated to each Prize Division/category.

Prize

A prize won by a player in any National Lottery Game.



Prize Fund

Shall be a percentage of the net sales for a draw or such larger amount e.g. Guaranteed Jackpots.

Prize Structure

The number, value and odds of winning Prizes for the DAILY LOTTO & DAILY LOTTO PLUS Game(s) as determined by ITHUBA from time to time.

QUICK PICK

An automated random selection of numbers on behalf of the player by PLS. This can be requested directly from the Retailer or selected on the player's Bet Slip and/or from any of the participating alternative channels.

Receipt/Ticket

A National Lottery Receipt/ Ticket issued through a Retailer by the Terminal (or Alternative Sales Channel) to a player which records a player's Entry or Entries into the National Lottery Games, pay-outs for claims.

Retailer

Any person, firm or entity authorized by ITHUBA to sell National Lottery Games Entries and/or to pay certain Prizes in respect of a Valid Winning Game Ticket.

Rules

The approved game rules and regulations for the National Lottery as detailed herein, and as may be amended from time to time.

Selection

A set of numbers chosen by a player as their entry for the draw.

Serial Number

The unique number assigned by PLS and printed on a Ticket.

Site

The website of the National Lottery; www.nationallottery.co.za

Terminal

The point of sale device with an on-line connection to the PLS, which shall be used for the issuance of valid Ticket(s), and for the validation of Valid Winning Ticket(s) and cancellations of tickets.



Ticket

Ticket issued by a Terminal and sold by an authorised Retailer in an authorised manner or sold via Alternate Channel/s that indicates the unique number that will serve as evidence for Prize claim.

Ticket Validation Requirements

ITHUBA's validation requirements for Ticket/s representing winning numbers for that specific Draw.

Valid Winning Ticket

A winning DAILY LOTTO and DAILY LOTTO PLUS Ticket which meets all ITHUBA's DAILY LOTTO and DAILY LOTTO PLUS Ticket Validation Requirements, from time to time.

VAT

Value Added Tax levied in terms of the VAT Act No. 89 of 1991, as amended.

Winning Selection

A Selection which entitles a Participant to a Prize in the category applicable to the randomly selected winning number/s.
